1. Renaming of the Centre for Online Education:

3. Applying to UGC for New Online Degree Programmes

The Member Secretary informed the committee that the MBA in Digital Marketing and Regular MCA programmes were approved by AICTE but not yet by the UGC.

Resolution:

The Chairman, after brief discussion, opined that to incorporate the Regular MCA programme and MBA in Digital Marketing, it is necessary to make some adjustments. One option is to consider replacing one of the existing PG Diploma programmes with the Regular MCA programme, preferably the PG Diploma programme in Cyber Security and Cloud Computing, as the same specialization is available under the MCA Programme. Hence, the Chairman and members of the committee unanimously recommended withdrawing the PG Diploma programme in Cyber Security and Cloud Computing and replacing it with the Regular MCA Programme. The Chairman pointed out that UGC has approved a total of 12 programmes (03 UG and 09 PG), leaving an option for including one additional PG Programme. Hence, MBA in Digital Marketing may be applied for, resulting in 03 UG and 10 PG Programmes under the entitled category.

4. **Articulation of Vision, Mission, Functions, Quality Monitoring Mechanism of CIQA for VTU Online Degree Programmes:**

The CIQA committee had a thorough evaluation and articulated the Vision, Mission, Functions, Quality Monitoring Mechanism of CIQA along with the brochure (enclosed in Annexure - 3). The committee unanimously recommended the same.





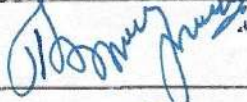
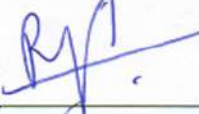


- **Vision:** The Vision of CIQA at Visvesvaraya Technological University (VTU) Online Degree Programmes is to establish and uphold a culture of excellence in the delivery of online education. CIQA aims to ensure that all online programmes are of the highest quality, meeting national and international standards of education. It strives to foster continuous improvement through systematic evaluation, innovative practices, and adherence to regulatory guidelines. This vision aligns with VTU's overarching mission to provide globally competitive technical education and to promote research and innovation in emerging technological fields.
- **Mission:** The Mission of the Centre for Internal Quality Assurance (CIQA) for Visvesvaraya Technological University's (VTU) Online Degree Programmes is to ensure and enhance the quality of online education through systematic and continuous improvements. CIQA aims to implement effective quality assurance mechanisms, foster a culture of continuous improvement, ensure adherence to regulatory guidelines, promote professional development for faculty and staff, and enhance learner support systems. By focusing on these core objectives, CIQA is committed to delivering high-quality, accessible, and innovative online education that aligns with national and international standards and meets the evolving needs of modern learners.

● **Functions of CIQA:**

- ✓ To maintain quality in the services provided to the learners.
- ✓ To undertake self-evaluative and reflective exercises for continual quality improvement in all the systems and processes of the Higher Educational Institution.
- ✓ To contribute in the identification of the key areas in which Higher Educational Institution should maintain quality.
- ✓ To devise mechanism to ensure that the quality of Online Learning programmes matches with the quality of relevant programmes in conventional mode.
- ✓ To devise mechanisms for interaction with and obtaining feedback from all stakeholders namely, learners, teachers, staff, parents, society, employers, and Government for quality improvement.
- ✓ To suggest measures to the authorities of Higher Educational Institution for qualitative improvement.
- ✓ To facilitate the implementation of its recommendations through periodic reviews.
- ✓ To organize workshops/ seminars/ symposium on quality related themes, ensure participation of all stakeholders, and disseminate the reports of such activities among all the stakeholders in Higher Educational Institution.
- ✓ To develop and collate best practices in all areas leading to quality enhancement in services to the learners and disseminate the same all concerned in Higher Educational Institution.
- ✓ To collect, collate and disseminate accurate, complete and reliable statistics about the quality of the programme(s)
- ✓ To ensure that Programme Project Report for each programme is according to the norms and guidelines prescribed by the Commission and wherever necessary by the appropriate regulatory authority having control over the programme;

- ✓ To ensure the proper implementation of Programme Project Reports by designing a suitable mechanism.
- ✓ To maintain our cord of Annual Plans and Annual Reports of Higher Educational Institutions, review them periodically and generate actionable reports.
- ✓ To provide inputs to the Higher Educational Institutions for restructuring of programmes in order to make them relevant to the job market.
- ✓ To facilitate system-based research on ways of creating learner centric environment and to bring about qualitative change in the entire system.
- ✓ To act as a nodal coordinating unit for seeking assessment and accreditation from a designated body for accreditation such as NAAC etc.
- ✓ To adopt measures to ensure internalization and institutionalization of quality enhancement practices through periodic accreditation and audit.
- ✓ To coordinate between Higher Educational Institutions and the Commission for various quality-related initiatives or guidelines.
- ✓ To obtain information from other Higher Educational Institutions on various quality benchmarks or parameters and best practices.
- ✓ To record activities undertaken on quality assurance in the form of an annual report of Centre for Internal Quality Assurance.
- ✓ It will be mandatory for Centre for Internal Quality Assurance to submit Annual Reports to the Statutory Authorities or Bodies of the Higher Educational Institution about its activities at the end of each academic session. A copy of report in the format as specified by the Commission, duly approved by the statutory authorities of the Higher Educational Institution shall be submitted annually to the Commission.
